Tax Returns:

The work performed will not include procedures to discover defalcations or other irregularities, should any exist. Information:

In the event of such government tax examination, I may be available upon request to represent you. Representation beyond the level included in the services selected will be a separate engagement. When a tax examination results in additional taxes, interest and penalties are normally added to the balance payable to the government. It is understood that interest and penalties resulting from a tax examination are the responsibility of the taxpayer.

Fees:

The fee for preparation of your tax returns will be based on the complexity of schedules and/or the time required, plus any out-of-pocket expenses. Fees are due upon delivery or prior to electronic filing. Any additional services rendered will be billed separately. This may include separate planning engagements, other tax returns, or correspondence to resolve disputes with taxing authorities, audits or other representation.
